Norman and Pamela Gaston want to build a new storage shed in the rear of their property located at 12985 University Road, Shabbona, in unincorporated Milan Township. The DeKalb County Zoning Ordinance restricts the height of such accessory buildings to not exceed the height of the house. However, the proposed 40' x 64' building would be approximately 21'8" tall, while the house is only 19'1" tall. In order to allow the new storage shed, a Variation must be granted from the height restriction.
