**Health and Human Services Committee Minutes  
November 4, 2013**

The Health and Human Services Committee of the DeKalb County Board met on Monday, November 4, 2013, at 6:30 p.m. in the Administration Building's Conference Room East. Chairman DeFauw called the meeting to order. Those Members present were Mr. Johnson, Mr. Metzger and Mr. Tyson. Mr. Emerson and Mr. Whelan were absent. Others present were Donna Moulton, Amanda Christensen, Anthony Cvek and Theresa Aubele.

**APPROVAL OF THE MINUTES**

It was moved by Mr. Johnson, seconded by Mr. Tyson, and it was carried unanimously to approve the minutes from October 7, 2013.

**APPROVAL OF THE AGENDA**

It was moved by Mr. Metzger, seconded by Mr. Johnson, and it was carried unanimously to approve the agenda.

**REGIONAL OFFICE OF EDUCATION ANNUAL REPORT**

DeKalb County Regional Office of Education Superintendent, Amanda Christensen, was present to deliver her annual report to the Committee. The report detailed the department's mission statement, staffing and duties, along with the ROE's community outreach and additional community / school activities. Ms. Christensen highlighted that they organize and run the DeKalb County Spelling Bee at Kishwaukee Collage that is sponsored by Shaw Media. The champion of the Spelling Bee wins a trip to Washington D.C. to compete in the National Spelling Bee.

Ms. Christensen shared that the Illinois State Board of Education changed everything July 1, 2013. They got rid of two of their old information systems that ROE uses and one that educators use to combine them into one system. She informed the committee that the new system went up July 1<sup>st</sup> and went down July 2<sup>nd</sup> and did not go back up until the day after Labor Day. Because of the program being down so long the department is unable to retrieve data that they were used to being able to obtain.

Some statistics that Ms. Christensen gave was that during the 2012-2013 school year the ROE processed 149 new and 7 duplicate certificates, and 44 endorsements and passed out over \$10,000 in registration fees. The ROE also maintains a database of all substitute teachers in DeKalb County and 470 teachers served this 2012-2013 school year.

The ROE is also the licensed fingerprinting vender in the area. They not only fingerprint anyone who goes into the school but also print healthcare workers, school volunteers, and county jail volunteers. Because they are the only licensed fingerprinting vender in the area they will also be the location in the future for people to come to get fingerprinted for conceal carry permits, which the ROE has been trained on and obtained the proper procedures for already.

During the 2012-2013 school year, DeKalb County Truancy Intervention Program provided service to 233 truants and 106 chronic truants and 45 potential dropouts in DeKalb County. Ms. Christensen also shared that during the 2012-2013 school year, 319 homeless youth were served in DeKalb County.

Ms. Christensen also covered GED testing, certification of bus drivers, building inspection, professional activities and fund distribution. You can find the full Regional Office of Education Annual Report covering July 1, 2012 to June 30, 2013 attached to these minutes.

## **FEED 'EM SOUP**

Theresa Aubele from the Feed 'Em Soup organization came to speak to the Committee on what they do and offer to the public. She explained that Feed 'Em Soup started in January of 2010 with a group of friends that saw a need in the community and put together some soup and peanut butter and jelly sandwiches to serve to about 50 residents. The last two years increased by serving meals every two weeks and now this year Feed 'Em Soup is serving meals every Wednesday evening to an average of 300 residents.

Feed 'Em Soup is located at 122 S. First Street in DeKalb and their community kitchen is open every Wednesday from 5pm – 7pm. They operate on a “donate-what-you-can” basis. Most of the guests eat for free. Some donate a dollar or two and others are able to leave a donation large enough to cover the food cost for multiple tables. Ms. Aubele also shared it is a restaurant style atmosphere and all residents are welcome.

Ms. Aubele explained the different areas they have at their facility that include their community kitchen, clothing closet, hope gallery and Lexi's Kids Corner. Ms. Aubele is the Director of Lexi's Corner and it is a program that runs on meal days and is open to children of all ages and is free of charge. Each program follows a particular theme and features a story and an art project, science experiment, game or other activity.

Ms. Aubele also shared different ways people can get involved with the organization which included donating and volunteering. There are many opportunities to volunteer that include helping on Wednesday evenings, meal preparation during the week, helping with fundraisers and many more. She also gave a briefing on upcoming events that Feed 'Em Soup is hosting.

Chairman DeFauw asked Ms. Aubele how the organization is supported. She answered that Feed 'Em Soup is supported by private donations, grants and fundraisers. They receive no funding from the State of Illinois or the Federal Government.

Mr. Tyson shared with the Committee that he has been taking residents to Feed 'Em Soup for a long time and shared how much he is in support of the organization and encouraged the other Committee Members to visit and consider donating to the clothing closet.

Mr. Metzger asked if their website has a wish list set up for items and food donations. Ms. Aubele answered that all of that information was provided on their website along with food facts and upcoming events and information on various programs. The website is [www.feedemsoup.org](http://www.feedemsoup.org) and they also have a Facebook page.

Lastly Ms. Aubele shared that Feed 'Em Soup is in the running for an RK Dixon \$15,000 Office Makeover. She shared that there is a link on their Facebook Page to vote.

The Committee thanked Theresa Aubele and Amanda Christensen for their presentations.

### **Contact Information**

The office is housed in the Community Outreach Building, a DeKalb County government building, at 2500 N. Annie Glidden Road, Suite C, DeKalb, Illinois, 60115. The main phone is 815-217-0460 and the fax number is 815-217-0467.

Hours are Monday—Friday (8:30 am—12:00 pm and 1:00 pm—4:30 pm).

Our office policy mandates prompt and courteous attention to all requests coming to our office for information and assistance with educational problems. This applies to phone calls, office visits and letters from school personnel, parents, students, and citizens. This is a year-round, daily service and constitutes one of the greatest single demands on our collective time and energy.

### **Duties of the DeKalb County Regional Office of Education**

The Regional Superintendent of Schools is the chief administrative officer of a Regional Office of Education and is the only elected education professional in Illinois. The Regional Superintendent of Schools is often referred to as an intermediate school officer. Most of the duties and functions performed are at a level between that of the local school district and that of the State Superintendent of Education. The Regional Superintendent and Assistant Superintendent coordinate and deliver state and local news as well as act as advocates by providing positive leadership and proactive assistance to educators, school districts, and the public. One of the most time-consuming tasks is assisting the Illinois State Superintendent of Education and his staff in processing the great number of applications, reports, claims for reimbursement, etc., which are required in today's education world.

- Respond to legal questions from educators, boards of education and other citizens
- Issue, register and renew teacher certificates
- Supervise and assist in transportation programs and other staff development programs
- Administer the G.E.D. testing programs and issue diplomas
- Disseminate information on scholarships and teacher vacancies
- Conduct professional growth opportunities
- Approve school calendars, in-service days, workshops and institutes
- Conduct hearings for School Districts reorganization
- Administer Truancy Intervention programs and Safe School Alternative Education programs

#### **Cooperation Management**

- Assist the Illinois State Board of Education (ISBE) in the evaluation and recognition of public schools, and private schools who ask to be recognized
- Maintain maps of all school districts
- Administer cooperative programs
- Monitor public schools during strikes
- Remove any member of a school board for failure to perform official duties
- Assist with cooperatives, special education programs and vocational programs
- Serve as Ex-Officio secretary of the Regional Board of School Trustees

#### **Financial**

- Audit district claims for General State Aid, categorical funds, and Federal grants
- Review budgets, audits, evidence of indebtedness and annual financial reports
- Check bonding of school treasurers

- Promote and support educational programs and achievements of the schools and educators
- Hold public hearings on topics vital to education
- Serve as liaison between the state legislature, local school districts, and the ISBE

## **Community Outreach**

Another significant duty of the ROE concerns serving as the educational representative on many of the professional and lay committees established throughout the County and Northern Illinois. The number of meetings involved with these committees is quite large and requires that the Superintendent and the Assistant carefully schedule for day and evening meetings each month to fulfill these requirements. The DeKalb ROE is always looking for ways to build a network of support for DeKalb County's youth.

## **Services to Educators Regarding Certification**

The Regional Office of Education assists teachers seeking an Illinois Teaching Certificate, including applications, registrations, endorsements, and renewals. During the 2012-2013 school year the ROE processed 149 new and 7 duplicate certificates, and 44 endorsements. We processed over \$10,000 in registration fees. The Regional Superintendent is also responsible for approving professional development for teacher certification renewals. Data is unavailable this year for the number of teachers whose renewals were processed due to the change in ISBE's informational system.

One of the most significant tasks for the 2012-2013 year was to be the resource for local educators as certification transitioned into a licensure system effective July 1, 2013. The Regional Superintendent visited most of the DeKalb County school districts and private schools and made presentations on the new licensure system and rules for administrators, teachers, and paraprofessionals.

The ROE maintains a database of all substitute teachers in DeKalb County. All substitute teachers can guest teach in all of the school districts and private schools in DeKalb County. 470 teachers took advantage of this service during the 2012-2013 school year.

New to the 2004-2005 school year was a law requiring a fingerprint-based criminal background check for all new hires, including substitutes. New to the 2011-2012 school year was a law requiring this same background check for all student teachers. As a result, the Regional Office of Education has a digital fingerprinting system that allows a quick return of criminal background information to the local school districts at a cost of \$60.00 per employee or student teacher. The ROE also provides this service to bus drivers, healthcare workers, school volunteers, and county jail volunteers. Fingerprinting is typically available by appointment daily 1:10 pm—4:00 pm. The office fingerprinted a total of 1,554 people last year.

### **Northwestern Illinois Association**

The Northwestern Illinois Association (NIA) is located at the Sycamore CUSD 427 Administration Building, 245 W. Exchange St., Sycamore. N.I.A. is an association of public school districts in the ten northwestern counties of Illinois, which provides services to children with severe sight or hearing problems and youngsters with multiple handicaps. A large geographic area is needed in order to provide an effective and economical program since a very small percentage of children are found in these categories. Ms. Laura Frankiewicz is the NIA director, and the Sycamore district is the administrative district. Assessing the member school districts in the ten county area provides some funds, but major financial help comes from state and federal grants of different types. These are mainly Title I and Title IV of the Elementary and Secondary Education Act. Public Law 94-142 provides substantial funds to NIA which, in turn, provides various amounts of these funds to county cooperatives for the local school districts.

### **Kishwaukee Education Consortium**

Serving DeKalb, Genoa-Kingston, Hiawatha, Sycamore, Hinckley-Big Rock, Indian Creek, Sandwich, Somonauk and Rochelle

KEC is the Regional Safe School Program, providing alternative education to students who have not found success in the traditional school setting. This program is part of the ReStart program which gives students the opportunity to "restart" their academic, social, and emotional growth.

During 2012-2013, ReStart enrollment was 150 students.

**Regional Board of School Trustees**

The Regional Superintendent acts as ex-officio secretary for the Regional Board of School Trustees. This board holds title to all school real estate in the name of the State of Illinois. The Board hears district consolidation cases and cases in which individuals wish to detach from one district and annex to another district. There were no such petitions for annexation filed in 2012-2013. Members of the Board are elected for six-year staggered terms by countywide elections indicated as follows:

**In-Service Training of Teachers**

Fees from the registration of teachers' certificates are available for teachers' institutes, workshops, and related activities. During 2012-2013, the Regional Office made these funds available to local school districts and cooperatives on a formula basis to these in-service training programs that could be directed toward local school needs. During the past year a total of \$13,605 was provided to local school districts to finance their own institutes approved by this office. The Regional Office of Education also coordinated and facilitated (9) Superintendents' meetings and (1) Principals' meeting.

Additionally, while not supported from the institute fund, the ROE held their annual Homeless / Truancy Workshop in June 2013. The workshop had 70 participants, including homeless liaisons, registrars, secretaries, teachers, administrators, and counselors.

**Truancy Supervision**

This was the twenty-sixth year that DeKalb County was part of a Truants' Alternative Optional Education Program. DeKalb County Truancy Intervention Program (DCTIP) was funded through a grant from the Illinois State Board of Education and was administered and facilitated through the Regional Office of Education, with the Assistant Superintendent serving as DCTIP Director. Truancy Outreach Workers Christine Underwood, Cathey Stoddard, Denise Curran and Mary Curran, worked with truant students and their families to improve attendance by providing early intervention services, acting as a liaison between home and school, referring children and families to DeKalb County service agencies, and coordinating a credit-recovery program. While early interventions are preferred, the DeKalb ROE appreciates working with DeKalb County Court Services.

During the 2012-2013 school year, DCTIP provided services to 233 truants and 106 chronic truants and 45 potential dropouts in DeKalb County:

**GED Testing and Issuance**

The General Educational Development (GED) is a battery of high school equivalency tests. Upon registering for the GED (\$50), the individual is given one year to pass all tests or they must re-register to complete unfinished/failed tests. Upon completing requirements, the individual is issued a GED (high school equivalency) certificate. In 2013 the DeKalb ROE began the process of becoming an official Pearson VUE testing site in order to administer the new 2014 computer-based test. The ROE thanks Joanne Kantner, her assistant Tricia Hernandez, and the rest of her staff at Kishwaukee Community College for the outstanding cooperation continuously received. The ROE has received additional assistance from the Illinois State Board of Education staff, the surrounding area ROE offices, the Illinois Community College Board and GED offices. During 2012-13, the DeKalb ROE issued a total of 226 certificates and/or transcripts, not necessarily for new applicants only.

**Services for Homeless Students and Their Families**

The McKinney-Vento Act, signed into law in Illinois on January 24, 1995 ensures that students who are considered homeless maintain consistent school attendance with minimal disruption. During the 2012-2013 school year, 319 homeless youth were served in DeKalb County. Denise Curran served as the DeKalb County Homeless liaison, training school district personnel in identifying homeless children and those in housing crises and providing the supports necessary to ensure consistent school attendance with minimal disruption. The DeKalb ROE appreciates Hope Haven and Safe Passage for their support of homeless students and their families.

## **Certification of Bus Drivers / Transportation**

The Regional Office is responsible for conducting the initial training required for all new school bus drivers prior to getting a bus permit and the annual refresher workshop required in the 12-month period prior to renewal. Experienced drivers must take a two-hour refresher course annually, and all new drivers must take an eight-hour course in school bus driver safety and first aid, as prescribed by the Illinois State Board of Education and administered by the ROE.

Four initial courses were held at the Regional Office of Education, and were taught by Kathy Jurs-Nelson, Charlene Bridges, John Leech and Tom Boyce. 57 drivers were trained at these sessions.

Two-hour refresher courses were provided on 8 occasions, mostly on location at our school districts. A total of 435 drivers attended these trainings.

Additionally, the Assistant Superintendent facilitated 4 Transportation Directors' meetings.

## **Recognition of Schools**

The DeKalb County ROE issued, in conjunction with the Illinois State Board of Education, a Certificate of Recognition to each of the eight public school districts in DeKalb County, and two non-public schools (St. Mary Elementary in DeKalb, and St. Mary's Elementary in Sycamore).

The Regional Office also conducted a full state recognition compliance visit to the Sycamore school district in the 2012-2013 school year. The following districts are scheduled for visitation for the 2013-2014 school year: Hiawatha CUSD 426, DeKalb CUSD 428, Hinckley-Big Rock CUSD 429.

Compliance items cover a broad range, including: personnel files and properly credentialed employees, student records, school improvement plans, special education services, board policy, website requirements, treatment of homeless students, staff evaluation methods and procedure, and mandatory staff trainings.

## **Health / Life Safety and Inspection of Buildings**

- Interprets Life Safety Code information for school officials
- Inspects every public school every year (43 buildings)
- Issues building permits
- Conducts walkthroughs of construction sites with architects
- Issues occupancy permits
- Maintains records of districts' 10-Year Surveys and Amendments
- Processes school maintenance grants and use of health-life safety funds

## **Professional Activities**

It is expected that the ROE staff will engage in continuous improvement. Both the Superintendent and the Assistant Superintendent are required to complete one Administrator Academy per year and an average of 20 professional development hours per year in order to maintain their educator credentials. Professional development hours for both administrators far exceeded this minimum requirement, including participation in:

- state-wide meetings and area meetings of Regional Superintendents of Schools
- behavioral threats assessment and safety/security workshops
- Common Core State Standards
- Partnership for Assessment of Readiness for College and Career (PARCC)
- 5 Essentials Survey
- School improvement and Rising Star
- GED testing
- Health / Life Safety building requirements
- Legislative updates

Truancy staff annually attends the ICEARY conference (Illinois Coalition for Educating At-Risk Youth). Office personnel regularly receive staff development for educator licensure, legislative mandates, criminal background checks, technology, and accounting.
