OLD BUSINESS / NEW BUSINESS

Chairman Metzger read the following letter dated March 19, 2014 from DeKalb County Administration staff Gary Hanson, County Administrator and Paul Miller, Planning Director and Deputy County Administrator for Operations, aloud to the County Board:

It is unfortunate that we find ourselves needing to submit this letter. In short, we are no longer convinced that the County is in a position to successfully complete the \$7.1 million grant-funded project of purchasing the Evergreen Village Mobile Home Park. This in turn means we cannot use already approved grant funds to relocate the residents of that Park to affordable and safe housing which will take them out of harm's way. The grant funds only allow us to pay \$1.47 million for the acquisition of the property and that offer has not been accepted as of today.

As you know, the County received a 3-year grant from FEMA in June of 2012 to purchase the Evergreen Village Mobile Home Park and relocate the residents out of the floodplain. Since then, the County has followed all of the many Federal and State required steps in this complicated project, up to and including making an offer at the end of October, 2013 to purchase the property for \$1.47 million. This offer was based on a professional appraisal that was reviewed and approved by the State of Illinois. It should be noted that the State requires the purchase offer to be based on a professional appraisal, not a negotiated process.

The owner of Evergreen Village, Mr. Frank Santoro, rejected our offer in November, 2013 and indicated he wanted to get his own appraisal. Under the terms of the grant, he had the right to reject our offer, and it was his right to submit his own appraisal to the State. That counter-appraisal came in February, 2014 which set the value of the Mobile Home Park at \$2.6 million, or about \$1.1 million more than the County's appraisal.

On March 5, 2014 Staff met with Mr. Santoro and his attorney to reiterate the original purchase offer of \$1.47 million. This amount, according to the grant rules, is all that the County can offer, unless the State approves a higher appraisal, and only if monies are available to pay that higher amount. Mr. Santoro was told at that meeting that neither the County nor the State had additional monies to put into this project. Staff then requested an answer from Mr. Santoro on the County's purchase offer no later than March 18, 2014. We should note, as an aside, that the State subsequently rejected Mr. Santoro's appraisal.

As of this morning, March 19, 2014 Mr. Santoro has not accepted the offer of \$1.47 million. The County remains committed to this project, and very much wants to move the residents of Evergreen Village out of harm's way. We cannot, however, allow the project to remain in limbo indefinitely, not only because there is a three-year deadline that is rapidly approaching, but because it is unfair to keep the residents on hold, not knowing when, or even if, the County might work with them to purchase their homes. Given that the rules require the voluntary participation by the property owner in the acquisition of the property, and that as of March 19, 2014, the property owner has not accepted the offer of \$1.47 million tendered to him in October, 2013, we are recommending that the Chairman direct the Planning and Zoning Committee to consider, at its March 26, 2014 meeting, the attached Resolution to cancel the County's participation in this project. Again, this recommendation is made reluctantly, but Staff thinks the time has come to face the reality that this project is not moving forward and so we must then bring it to a conclusion. Following review by the Planning & Zoning Committee, we ask for formal Board action at its April 16, 2014 meeting.
