# Mapping Software-

- G. Johnson Reported- There was a fiber meeting 12-02-14. DATA felt that they could get Sandwich PSAP live using existing fiber and some repurposed equipment but the configuration of the routes would need to be worked out. Could possibly be live in January.
- There will be a map meeting next week to discuss the data hand off and the impact of the change of Sandwich Police Department off the DeKalb Police CAD server
- Inter-agency agreements may be needed between the ETSB and DeKalb Police Department

#### **NEW BUSINESS**

- Sandwich Police Department request-
  - Chief Bianci and Mayor Olson from Sandwich discussed their request to have the fiber moved to the new location of the Police Department, all charges dealing with 911 and administrative lines. They also wanted to request that the monies for the dispatch workstations/furniture stay in the 2015 budget for the new police department. The cost to move the fiber could be possibly is around \$80,000.00. G. Johnson to get an accurate price.
  - There was a discussion of what was paid for dealing with the DeKalb Police Department to make sure each was treated equally.
  - A motion was made by Hanson to pay up to \$80,000.00 for the fiber move and also all lines to be moved to the new Sandwich Police Department and it was seconded by Jones. A roll call vote was taken: Chairman King- Y, Hanson- Y, Hicks- Y, Jones- Y, Leverton- Y, Merritt- Y and VanLanduyt- Y. Motion passed.
