NEW BUSINESS

911 Calls- Address issue

- Johnson introduced Chris Halstead from DeKalb County Information Management Office. Halstead stated she has been working on the 911 addresses dealing with the county Cisco phone system. Test calls have displayed incorrect addresses. There has been confusion on the database holder and corrections of that data. There was a meeting with their database provider. Johnson stated that Halstead has been working very diligently on this issue to make sure all address and call routing is correct.
- Hanson mentioned the process that Johnson had sent out letters previously to the entities that must meet the state law dealing with structures of 40,000 square feet or larger. Johnson stated she only works with systems as the errors come in and have not followed up with every entity since the original notification.

 G. Johnson discussed the implementation into the PSAPs is moving slowly. Nothing new beyond that.
