OLD BUSINESS

Fire Radio Reports

- Feyerherm stated the Malta radio connection is in the process of installation. He
 is concerned with the delay. Hinckley tower radio connection will be live the
 next week. King asked G. Johnson to get in contact with NIU before the next
 meeting.
- Waterman radio building- Feyerherm discussed a picture of the roof of the building that needs to be repaired. He will bring pricing to the ETSB on pricing of a monitoring system called Centra voice when the temperature rises in the building. This would notify the Sheriff PSAP. There was a repair call in June at this site.

Mapping Software-

- Sandwich Fiber was installed in June.
- o Inter-governmental agreements are in the works.
- o Johnson still needs to order computers for all Sandwich and NIU.

NEW BUSINESS

Somonauk Police Dispatch-

- o Introductions were made of all in attendance to the meeting
- Larry Nelson stated that KenCom 911 Dispatch had contracted with the Somonauk Police Department for dispatch services.
- o Intergovernmental agreements will be needed between both ETSBs if approved by the DeKalb ETSB for routing of the 9-1-1 calls.
- Each 9-1-1 System utilizes different 9-1-1 System providers and that is an issue that needs to be investigated on call detail.
- Stoffels stated he is not aware that this issue had ever been done in the state where you split the Police and Fire for routing of the calls.
- o There was a discussion that there needs to make sure proper service is provided.
- There needs to be a face to face meeting to work out all the possible issues with this change.
- It was discussed that not all the ETSB should be attending the face to face meeting so VanLanduyt was appointed to attend along with G. Johnson. It was also discussed that KenCom would be the lead on coordinating the face to face meeting.
- Nelson stated it was case law where the calls are to be routed first based of Police calls.
- Johnson reiterated that the DeKalb ETSB is the final decision of where the 9-1-1 call is routed to no other entity and that this change will need to be approved by the ICC.
- o There was a discussion on the current MSAG status for the Village of Somonauk.

• Frontier Bill Increase- Johnson stated no new information

NG911 Update-

- Johnson stated the RFP approved by all ten States Attorneys.
- o Meeting the following week to discuss release dates and site visits etc.
- Johnson discussed the Phase 2 addition of the Kimball contract. Jones made a motion to approve this additions and it was seconded by Leverton. Motion passed.

Coordinators Report-

- Lightning Strike- Johnson stated that the High Rise radio location had been struck on July 13, 2015. She had sent a letter out to the ETSB shortly after the strike had happened to notify them of the expense. The amount of equipment and labor for the repairs would be approximately \$15,000.00. She did give the approval that day to purchase the replacement equipment because there was another storm expected that same week and the spare may be needed at that point. The spares did come in and were not needed again. Insurance was notified of the strike.
- Wireless Check- The last check for the wireless monies will be issued in August but if the State Budget is not approved then the ETSB will not receive checks until it is resolved.
- Arrears report- There are companies that are delinquent and she will follow up with them to see if they have no customers in the county or pay quarterly etc.
- o **INENA Region VP 3 office** she was nominated to continue in that position.
- Genoa Day Care Public Education- She had gone twice to this day care to discuss
 911. Lisa Winckler went with her to help with the 911 Simulator the last day.
- County Dispatch Board- Last meeting was on 06-03-15, no meetings will be set until the chairman has a chance to review old minutes from meetings for the fire department dispatch discussion. Johnson met with the City of Genoa Police Department and City Manager.
