# Fire Radio Reports

# **NEW BUSINESS**

- Frontier Bill Increase- Johnson stated no new information
- NG911 Update- Johnson stated the RFP has been sent to all ten States Attorneys. NINGA
  is waiting for all responses.

# Legislation-

- **SB96-** Johnson stated the bill had made it through the House Representative and Senate. Waiting for Governor to sign the bill.
  - O Johnson reported on the 9-1-1 Advisory Board (SAB) current members will stay in place until they are reinstated or replaced. Johnson asked for the board approval to accept the position on the SAB if asked. Lowery made a motion to approve Johnson to stay on the SAB and seconded by Phillips. Motion passed.
- Consolidation/Waiver- There was a discussion of who would make the final decision of who would file the consolidation or waiver request. The law only talks about ETSBs or the Legal governmental entity in the absence of an ETSB.
  - There needs to be a review of Public Safety cost benefits of a consolidation or not. This will be a discussion item of the subcommittee.
     The subcommittee needs to do their own research once final details have been received.
  - o The ETSB will back the recommendation of the subcommittee.
  - o JCAR will need to write the rules once the legislation is signed.
  - Johnson will keep the ETSB aware of the progress of the legislation/report.
