### Health & Human Services Committee Minutes June 1, 2015

The Health and Human Services Committee of the DeKalb County Board met on Monday, June 1, 2015 at 6:30 p.m. in the Administration Building's Conference Room East. Chairman Haji-Sheikh called the meeting to order and those Committee Members present were Ms. Askins, Mr. Porterfield, Mr. Reid, and Mr. Whelan. Ms. Little was absent. The roll call reflected five members were present and one absent.

Others present were Dianne Leifheit, Deanna Cada, and Amanda Christensen.

#### **APPROVAL OF THE MINUTES**

It was moved by Mr. Whelan, seconded by Mr. Reid and it was carried unanimously to approve the minutes from the May 4, 2015 meeting.

#### **APPROVAL OF THE AGENDA**

It was moved by Mr. Porterfield, seconded by Mr. Whelan and it was carried unanimously to approve the agenda as presented.

#### **PUBLIC COMMENTS**

There were no public comments made.

#### CHAIRMAN'S COMMENTS

Chairman Haji-Sheikh shared two articles that were recently published in Northern Illinois University's Northern Now. The first article discussed was Hearts on State: In the Penguin Players, adults with disabilities take the stage under the guiding wings of NIU student mentors. The Committee also commended Ms. Jane Lux, Public Health Administrator for being awarded a 2015 Alumni Award through the Collage of Health and Human Services.

#### **STEPPING UP INITIATIVE – DEANNA CADA**

The Committee welcomed Mental Health Board Director Deanna Cada to share more in-depth information regarding a resolution the County Board passed last month from the National Association of Counties, the Council of State Governments Justice Center and the American Psychiatric Foundation.

Ms. Cada shared that she recently observed a webinar that detailed the Stepping Up Initiative. Through the webinar, she shared that each year there are an estimated 2 million people with serious mental illnesses admitted to jails across the nation. Almost three-quarters of these adults also have drug and alcohol use problems. Once incarcerated, individuals with mental illnesses Health and Human Services Committee Minutes June 1, 2015 Page 2 of 3

tend to stay longer in jail and upon release are at a higher risk of returning to incarceration than those without these illnesses.

The human toll of this problem and its cost to taxpayers is staggering. Jails spend two to three times more money on adults with mental illnesses that require intervention than on those without those needs, yet often do not see improvements to public safety or these individuals' health. Although counties have made tremendous efforts to address this problem, they are often thwarted by significant obstacles, including operating with minimal resources and needing better coordination between criminal justice, mental health, substance use treatment, and other agencies. Without change, large numbers of people with mental illnesses will continue to cycle through the criminal justice system, often resulting in tragic outcomes for these individuals and their families, missed opportunities for connections to treatment, inefficient use of funding, and a failure to improve public safety.

The resolution the County Board passed authorized the County Board Chairman to sign on to the Stepping Up program's "Call to Action" to reduce the number of people with mental illnesses in our county jail, commit to sharing lessons learned with other counties in Illinois and across the country, to support a national initiative, and encourage all county officials, employees and residents to participate in the Stepping Up program. The Stepping Up program's comprehensive resources consist of:

- Convene or draw on a diverse team of leaders and decision makers from multiple agencies committed to safely reducing the number of people with mental illnesses in jails, through new or existing committees.
- As available, collect and review prevalence numbers and assess individuals' needs to better identify adults entering jails with mental illnesses and their recidivism risk, and use that baseline information to guide decision making at the system, program, and case levels.
- Examine treatment and service capacity to determine which programs and services are available in the county for people with mental illnesses and co-occurring substance use disorders, and identify state and local policy and funding barriers to minimizing contact with the justice system and providing treatment and supports in the community.
- Examine development of a plan with measurable outcomes that draws on the jail assessment and prevalence data and the examination of available treatment and service capacity, while considering identified barriers.
- Explore implementation of research-based approaches that advance the plan.
- Collaborate on creating a process to track progress using data and information systems, and to report on success.

The Committee spent some additional time talking about the communities need for more resources to serve the mentally ill. Ms. Cada shared that the Mental Health Board's plan is to first focus on areas that they can strike quickly. The Committee also talked in length about Crisis Intervention training for law enforcement personnel.

Chairman Haji-Sheikh and the Committee thanked Ms. Cada for taking the additional time to come and give them further insight on this initiative.

#### **REGIONAL OFFICE OF EDUCATION – AMANDA CHRISTENSEN**

Chairman Haji-Sheikh introduced to the Committee Regional Superintendent of Schools Amanda Christensen. Ms. Christensen first shared her June 2015 Regional Reporter newsletter. The newsletter outlined the department's end-of-the-year state monitoring and compliance aspects. The Committee continued to review the newsletter and Ms. Christensen noted that she would have her full annual report available by fall.

Ms. Christensen also reviewed the trend data of homeless students served by DeKalb County's Regional Office of Education and the funding they receive in trying to assist with these students. Ms. Christensen also discussed her department's role in assisting students at Hiawatha School that were affected by the April 9<sup>th</sup> tornado.

Truancy referral data was also reviewed as well as grant funding that is awarded to truancy alternative educations programs. After discussion and running the numbers, Chairman Haji-Sheikh noted that is more money awarded to potential dropout students than there is to homeless students.

Ms. Christensen also shared with the Committee other duties her offices is assigned to such as building and occupancy permits for schools and detachment annexation petitions. Educator Licensure numbers for FY 2015 were reviewed as well as testing data that is administered through the ROE at the County's Community Outreach Building computer lab.

Mr. Reid engaged Ms. Christensen and the Committee to discuss adding civics training in schools. He noted that he feels it is very important for students to engage in civics training to become good citizens. Ms. Christensen shared that the Illinois Senate has approved legislation requiring that students take a civics course to graduate from high school. The bill, HB 4025, now goes to the governor for a signature. If signed by the governor, the legislation would take effect for the 2016-17 school year.

The Committee thanked Ms. Christensen for joining them and sharing her information and the duties of the DeKalb County Regional Office of Education.

### Letter from the Regional Superintendent

Now is the time to wrap up the school year. As school districts are busy with prom and graduation

ceremonies, and final exams, the ROE is busy finishing state monitoring reports. This year in DeKalb County, forty-three public school buildings and one private school building were inspected for Health and Life Safety violations. Now is the time that we are collecting responses and remedies from districts prior to the June 30 deadline.

School districts are also on a 3-year rotation for full compliance audits. Three school districts (Genoa-Kingston, Indian Creek, and Somonauk) were visited

this year by a team from the ROE made up of Jeff Smith, Barb Clark, and me. Compliance items range from mandated trainings to use of Title I funds to facilities operations to board member trainings. The area of technical assistance that takes the most significant amount of time to review is the personnel file and educator licensure requirements. All data collected are in the process of being compiled into the report to the Illinois State Board of Education.

Now is also the time for final public school calendars and General State Aid claims to be submitted for approval as well as school safety protocol annual reviews. As school construction projects start, the ROE also issues the necessary building permits and then, ultimately, the occupancy permit after work is completed before school starts.

Lastly, June is a very busy month for technical assistance to educators who need to renew and register their licenses. Any educator whose license is expiring June 30, 2015, must renew and register in order to be eligible to work! Any educators with questions should contact us as soon as possible and not put it off until June 29!






### Trend Data of Homeless Students Served by **DeKalb ROE**








