As in the past, they cannot do this without a tremendous amount of support from the community. The cost to get The Wall is \$7,500. Funds will also be needed for additional items, i.e. school field trips, sound equipment rental, chairs, staging, publicity, etc. that will be needed for the event. The goal is to raise \$20,000-25,000 in order to provide a respectful presentation of the Memorial. At this point there are no exact dates when The Wall will be here, however, the hope is that it will be September 14-17, 2017. Any money raised above what is needed for this event will be used to honor veterans in DeKalb County. There are also numerous opportunities for volunteers during the event.
