#### **OLD BUSINESS**

- Fire Radio Reports
  - Feyerherm reported:
    - Covered why the bill issued to the board for the heater at Keslinger was higher than approved by the ETSB in December. The issues were with the electricity. He stated he should have called Johnson to explain before moving forward.
    - He stated the Malta site was working properly and the NIU Technician was very helpful with the installation.
    - The Tower Rd site is installed.
    - He stated he was not positive of the procedure for notification when there is a fiber issue. Johnson thought that the proper procedure was to notify the NIU repair center. She will investigate and notify him of the proper policy.

 He stated that he had been notified of an issue with the Paw Paw coverage area. He will continue to work with Paw Paw Fire and Lisa to find out what is causing the issue.

#### Mapping Software-

 Johnson stated she needs to order the hardware to connect to the fiber and the new computers.

#### **NEW BUSINESS**

#### Purchasing/Procurement policy

o G. Johnson reported for C. Johnson that she is working on this document and hopes to have a copy for the ETSB to review within the next two months.

#### NG911 Update-

- Johnson stated:
  - NINGA has decided to split the costs by number of systems and number of positions for the final pricing depending on the product or service.
  - NINGA will be voting next week to go into negotiations with a Vendor for the Integrator. Polarek discussed whether the ETSB should officially give G. Johnson the authority on their behalf to proceed with negotiations.
  - A motion was made by Jones and seconded by Phillips to give G. Johnson the authority on behalf of the ETSB with NINGA to go into negotiations with the chosen vendor by NINGA and return to the ETSB with final costs from the vendor chosen by NINGA for the ETSB's approval at a meeting in the future. Motion passed.

#### Sub Committee Report-

- Johnson stated that there was no meeting of the committee since the last ETSB Meeting. The Fayette County Waiver that had been filed with the ISP most likely the ETSB will not be able to use as an example.
- Jones asked had the subcommittee looked at the fees for dispatching if 911 calls were moved to a different to be dispatched with consolidation. That is part of the data to be collected.
- Leverton stated the committee is brainstorming ideas right now. The committee will be meeting later in the month.
- Leverton stated that a motion needs to be made on the ETSB decision to ask for a waiver or not and wording had been sent to the ETSB for consideration.
- A motion was made by Bianchi and seconded by VanLanduyt to approve a consolidation waiver request with the Illinois State Police 911/State Advisory Board to be filed by June 30, 2016. Motion Passed.

A motion was made by VanLanduyt and seconded by Jones that if the consolidation waiver is not approved by the State Police 911/State Advisory Board and the ETSB is forced to reduce to two PSAPs within the county, the Sheriff's Department PSAP and DeKalb City PSAP will remain as the designated PSAPs to maintain the function of answering 911 calls, to be effective by the prescribed date as determined by the state board. Roll call vote was taken: Chairman Leverton- Y, Hanson- Y, Bianchi- Y, Hicks- Y, Jones- Y, Leverton- Y, Merritt- Y and Phillips- Y, Polarek- Y, and VanLanduyt- Y. Motion passed.

#### • **Legislation**- Johnson stated:

- HB 4521 and SB2338 are still in Rules Committee. This deals with the ability to sweep certain accounts to balance the State's budget.
- o State 911 Advisory Board:
  - The Advisory Board completed their report to the General Assembly prior to March 1, 2016.
  - Many Agencies were in attendance at the last meeting to present their case dealing with required consolidation.
  - An official waiver request has been filed and is being reviewed by ISP Staff to make sure it meets all requirements.
  - The Advisory Board has been tasked with reviewing RFP for a consultant prior to the next meeting.
  - The trailer bill SB0026 from last year dealing with Aurora language request in the current legislation is still to be considered.

#### Participating Agency Request-

- DeKalb Police Department:
  - Leverton asked the ETSB to approve an expense for him to attend the National NENA Conference in June 2016 in Indianapolis at the cost for the registration of \$599.00 and travel not to exceed \$1,500.00.
  - This is a chance for him to learn more about NG911 and network with other 911 System representatives.
  - A motion was made by Jones and seconded by Phillips to approve the expense. Motion passed.
- PSAP Managers Report- Johnson reported they met March 2, 2016 and discussed:
  - Training, Critical software locations, Consolidation/waiver, TC Week items to be purchased, Public Education items to be purchased for 2016, NINGA RFP status and Vender demoes.

- o Frontier Billing-

  - We are to receive copies of bills to verify with the State with zero figures for accuracy in the future.
  - We do have a large credit on the current billing.
