**PLANNING & ZONING COMMITTEE**

**Ordinance O2017-07: Establishing a Period of Assessment of Commercial Wind Towers and Commercial Solar Farms/Gardens**

Motion

Mr. Faivre moved that the DeKalb County Board hereby approves to clarify the intent of the Moratorium Ordinance O2017-02 and furthermore establishes a period of assessment of the real impacts, positive and negative, of any approved commercial wind farm, during which period there shall be no action on any Special Use Permit and Amendments to Special Use Permit applications for the construction and operation of commercial electricity-generating wind towers within unincorporated DeKalb County and no action shall be taken on commercial solar farms/gardens, said period of assessment to commence upon execution of this Ordinance and to continue for the remainder of the eighteen (18) months from when the initial Moratorium was adopted on March 15, 2017 or until a fully adopted sustainability ordinance is in place, whichever comes first. Ms. Askins seconded the motion.

*Mr. Faivre clarified that this Ordinance is to only remove solar systems/panels to be used on commercial or industrial rooftops from the original moratorium.*

**Ordinance O2017-08: Amending the Countywide Stormwater Management Ordinance for DeKalb County**

Motion

Mr. Faivre moved the DeKalb County Board concurs with the findings and recommendations from the Stormwater Management Committee and hereby adopts and replaces in its entirety, Attachment A: The DeKalb County Stormwater Management Ordinance Section 10.8. Mr. Roman seconded the motion as presented.

**Ordinance O2017-09: Approving a Zoning Map Amendment in Afton Township**

*Mr. Faivre noted that before they went any further with this Ordinance, it has been brought to his attention, by the State's Attorney's Office, in the last couple of days that this Ordinance is not in compliance with proper presentation. The Ordinance needs to meet one of four general forming principles and currently does not. The Committee can recommend granting the Ordinance as it was presented to the Hearing Officer with conditions, they can deny the Special Use Permit Amendment or they can send it back for another Hearing. The Committee did not follow any of those choices. Mr. Faivre expressed his sincere apologies on behalf of himself, as Chairman of the Planning & Zoning Committee, and on behalf of the other Members of the Committee that they missed this compliance piece. Mr. Faivre noted that he would like to move that this Ordinance be adopted and then following the second to the motion, he feels it would be appropriate for someone to make a motion to send this Ordinance Back to Committee to get it put back in the right format.*

**Ordinance O2017-13: Supplemental Ordinance Providing for the Issuance of General Obligation Bonds (Alternate Revenue Source), Series 2017, of the County of DeKalb, Illinois**

*DeKalb County Finance Director, Pete Stefan, introduced Mr. Kevin McCanna, Chairman of Speer Financial, Inc. Mr. McCanna explained that bids received today for the \$32,420,000 General Obligation Bonds (Alternate Revenue Source), Series 2017. There were three bids received. Upon examination, it is in Speer Financial's opinion that the bid of Robert E. Baird & Co., Inc., Milwaukee, Wisconsin, is the best bid received, and it is further in their opinion that the bid is favorable to the County and should be accepted. The proceeds of the Bonds will be used to finance the renovation and expansion of the County Jail, and to pay the costs of issuance of the Bonds. After the sale the par amount of the Bonds was adjusted to \$33,905,000. Speer Financial further recommended that the Bonds be awarded to that bidder at a revised price of \$33,407,929.50, being at a revised true interest rate of 3.5924%.*

Mrs. Haji-Sheikh also announced that 211 DeKalb County is now up and operational.




